## **Conditional Use Application:**

Zoning Officer Michelle Arner advised a parcel, Butz Landfill Site, would like to use the parcel as outdoor storage. The ordinance states that it must be stored inside. They have filed an application for Conditional Use. Solicitor Weitzmann advised it has to go before the Planning Commission. There is a 60 day deadline, which would be May 8, 2017.

Donald Kresge Sr. made a motion to refer the Conditional Use Application to the Planning Commission for their comments and to conduct a Public Hearing April 27, 2017 @ 6:00 PM. Motion seconded by David Thomas. All voted aye. Motion carried. Solicitor Weitzmann will advertise the hearing.

# Wallingford Road – Tom Shafer:

Zoning Officer Michelle Arner advised on 5/10/12 the Board of Supervisors approved a conditional use application. To date, the building has not been constructed and the time is running out. The property owner is requesting a 6 month extension to build the building. Solicitor Weitzmann advised a Developer's Agreement is needed, as well as posting a bond.

David Thomas made a motion grant the 6 month extension request. Motion seconded by Donald Kresge Sr. All voted aye. Motion carried.

#### **Vice Chairman David Thomas:**

Supervisor David Thomas advised he has been offered a federal job which prohibits him from continuing as Jackson Township Supervisor. A written resignation letter dated March 9, 2017 was given to the Board of Supervisors. The letter indicates the resignation is effective March 31, 2017. "I have enjoyed my service to the people of Jackson Township; however, I have accepted a position that will not permit me to continue to hold an elected office of any type. I'd like to wish you all the best of luck and continued success because as you succeed so do the residents you serve."

Donald Kresge Sr. made a motion to accept with regret the resignation letter of David Thomas. Motion seconded by Lester Wolcott. Both voted aye. Motion carried.
