Comments:

Township resident, Joseph Polinski, addressed the Board of Supervisors, requesting an update on the status of repairs on the bridge at the entrance of Mountain View Drive. The bridge weight was lowered by PennDOT. The Board of Supervisors and Road Master, Donnie Kresge, Jr. stated the bridge repairs are a major concern as there is only one way in and out of the development. Arrangements must be made for access to the neighborhood during repairs. Many options have been researched. Currently, plans are to have one lane available to enter and exit the development. This will certainly lengthen the timeline to complete repairs, but is necessary. The Township has applied for grants to assist with the cost. Senator Rosemary Brown, State Representative Jack Rader, surrounding municipalities and the County sent letters of support for the grant application process. Work on the bridge cannot begin prior to the grant being awarded. Township Engineers have the bid packet ready for advertising, once the financing is in place. The bridge repairs are a priority for the Township. The Township is working diligently to address the issue at hand. Joseph thanked the Board and appreciates the update.
